## Summer Success

Our annual Roast & Toast / Silent Auction at the Rochester Moose Lodge was great success again this year! Association supporters enjoyed an evening of delicious small plate summer fare from Evergreen Eatery here in Rochester. Lively music was provided by The Frito Pact, and friendly bidding was had on the wonderful array of silent auction items generously donated by local supporting businesses and families.

The attendees helped raise over \$10,000 for the Association's long-term mission of preserving, protecting and maintaining the ecological health and beauty of Lake Manitou and it's watershed. We are immensely grateful for the support and will be good stewards of every dollar in achieving this mission. We are also grateful for the joy of seeing community members come together for a wonderful evening as the summer comes to a close.

Hours of planning and efforts go into community gatherings like our Roast & Toast. Our volunteers, donors and bidders made the event a success! We thank them and encourage you to do the same.

Our successful summer also included the aquatic weed treatments conducted in July and August. We continue to see significant improvements in the volume of aquatic weeds after approximately 15 acres were treated. Dredging quotes are in and we are currently developing a committee to study areas where dredging may be needed. Once the study is complete, the committee will draft a proposal for permitting and funding of future projects. We have received an update from the Fulton County Soil & Water Conservancy regarding the samples taken from Lake Manitou's watershed. The study will continue through the winter and we look forward to the data and specific recommendations for projects that we can implement to improve the water quality coming into Rain Creek. Current results from the study are available on our website. And finally, we are working on having a firm come in to see what can be done to improve fishing on our lake. We will conduct an open meeting to discuss the information and data we receive, and will send notification of the meeting date once it has officially been scheduled.

We thank you for your continued support of our mission for Lake Manitou. We encourage you to enjoy the water with family and friends. Your support makes it happen!
