AOUATIC PLANT CONTROL

We continue to contract for Tier 2 testing to ensure the necessary plant life needed for our fishery and ecosystem is viable. With that assurance in mind, we have applied for aquatic plant control treatments designed to access areas most susceptible to plant affecting public navigation. The state allows us two (2) permits, one for the main portion of the lake, and one for what the state considers channel areas. In the map below, the "main" lake areas to be treated are highlighted in vellow. The "channel" areas are highlighted in blue. All areas in vellow are paid from the Association general fund. (Please note that if plants are not present, no treatment will occur in the particular area). All blue areas will require individual residents to apply and pay for treatments if residents in those areas wish to do so. NFW SIGNS



We are installing a new 4x8 informational sign at the boat ramp just north of the Elks Golf Course. We are also updating the sign at the north boat ramp on State Road 14 to remind everyone of the basic navigation and safety rules while enjoying the lake.

PRAIRIF / FCO 70NF

Now that the Prairie has been reduced in size, we need to add additional protection to the area. We will be installing dusk to dawn lights on the Prairie buoys for safer nighttime navigation. This area is marked off and registered with the state so they can enforce the no navigation rule. If you notice watercraft motoring through the Prairie/ Eco Zone, please report it to the DNR.

PERIMETER BLICYS

Based on Member input and concerns, we are adding nine (9) new lighted buoys along the perimeter of the lake.

Please remember that when navigating within the areas between the buoys and the shoreline, you must travel at idle speed and perpendicular to the shoreline (Navigating parallel to the shoreline poses a significant safety risk to swimmers).

If you notice a light not working on a buoy, please contact us so we can resolve the issue.

THE LAKE MANITOU ASSOCIATION WELCOMES YOU


- -All motorized boats must be registered
- A US Coast Guard approved life jacket / vest is required for each person on board
- Navigation lights must be displayed sunset to sunrise
- The maximum speed is 10 mph between sunset and sunrise
- Operators of boats over 10 horsepower must have a valid drivers license or be certified through a boaters course
- An observer must accompany the driver when pulling a skier, tuber, etc.
- Idle inside perimeter buoys perpendicular to shoreline (200 feet per law)
- No boats under power allowed in the Eco Zone

(marked with white buoys in the center of the lake)

SOIL & WATER CONSERVATION COLLABORATION

We are in the early stages of collaboration with the Fulton County Soil & Water Conservation District to create a more aggressive plan to reduce the amount of run-off into our massive 28,000 acre watershed. (See Map). Water testing, dredging projects to collect sediment and ongoing conservancy practices upstream are being considered as we move forward. As a resident, there are some simple ways in which you can help:



WHAT YOU CAN DO

- 1. Pick up your pet's waste
- 2. Use phosphorous free fertilizer
- 3. Dispose of yard waste (leaves, grass clippings) properly NEVER blow them into the lake
- 4. Install glacial stone along your concrete seawall this will reduce wave activity which helps to prevent erosion
- 5. Avoid feeding the ducks, geese and swans
- 6. Remove invasive plant species from your property
- 7. Don't use the lake as a bath soaps, detergents and shampoos are harmful to aquatic life
- 8. When operating your boat at high speeds, distance yourself from the shoreline, islands and shallow areas to avoid stirring up the lake bottom and causing harmful erosion
